Primary Purpose

The **Technician Wastewater TF** is responsible for the installation, maintenance and operation of Wastewater facilities and services throughout the Snowy Monaro Regional Council area.

Key Accountabilities

- Operate and maintain the Snowy Monaro Regional Council areas wastewater treatment plants in accordance with Environmental Licences for each plant,
- Possess a gook knowledge of the operation, maintenance and monitoring of wastewater treatment (coagulation and flocculation, sedimentation, filtration, disinfection ad biological treatment systems, laboratory equipment, disinfection equipment, fluoridation dosing equipment),
- Have a good knowledge of mathematical operations and calculations to indicate wastewater plant performance,
- Understand Material Safety Data Sheets (MSDS) and chemical hazards,
- Have comprehensive communication skills (written and oral skills sufficient to obtain and notify others of technical information)
- Operate in a range of sewerage operations, construction and maintenance works relevant to the Snowy Monaro Regional Council area wastewater operations section, including participation in the on-call roster
- Ensure that the DPI Water, EPA and NSW Health Department Sewerage treatment and effluent discharge standards are met by efficiently carrying out operational, maintenance and testing procedures at the appropriate Sewerage Treatment Works in accordance with Council's standards, timetable and quality objectives,
- Promote information sharing and knowledge transfer to drive evidence-based decision-making, enhance capability and optimise capacity

- Contribute to the performance of Council: demonstrate professional conduct, make the best use of knowledge, experience and skills and be accountable for own decisions and actions
- Contribute to a safe workplace: comply with legislative and organisational requirements and be accountable for own decisions and actions
